

Library card for children in Falun kommun, agreement

In Falun kommun all children who are 6 years or older can have their own library card. It is a personal document and your child can bring it home. We think it should be easy for everyone to borrow and read books.

Borrowing from the library

With the library card you can borrow books at the libraries in Falun, Bjursås, Svärdsjö, Vika and on the book bus. All loans will be registered by the library. You can borrow and return on your own in self-service stations, or you can ask the staff for help.

Library rules

The checkout period is typically four weeks. When a loan expires you can either return the book or renew the loan, unless the book has been reserved by someone else. Returning books in time can easily be forgotten. The library will send reminders to the parents/guardians by mail or e-mail, but children will not be fined if loans are overdue. Parents/guardians are responsible for books borrowed by their children and teens up to 18 years old.

Processing personal data

Personal data means identifying information relating to a living person, for example social security number and post address. The GDPR (General Data Protection Regulation) governs how Biblioteken i Falun processes personal data of your child.

The library will register your child's social security number or LMA-number in order to collect and update name and contact details through the Swedish Tax Agency. We also register the books borrowed. This allows us to keep track of loans made and to keep in touch. The legal basis for doing so is this agreement. The signed agreement can be collected and handed in to the library by a teacher of your child. Contact details to child and parent/guardian(s) will be stored so long as the library card is being used. Loaning history will be deleted continuously after books have been returned. Kultur- och fritidsnämnden in Falun kommun is responsible for GDPR compliance.

Through the GDPR you have a number of rights regarding processing of your personal data, including the right to information, the right to rectification and the right to object the processing of data.
